5	One orchid or anthurium or bromeliad not to exceed 50cm x 50cm	
6	One stem of any shrub in a vase to be named not to exceed 50cm x 50cm	
7	One bowl of roses, any number, any variety i.e. large flowered ex hybrid tees, cluster roses ex- floribunda and miniature roses.... not to exceed 75cm x 75cm	
8	An arrangement of spring flowers from your garden in a vase or bowl.... not to exceed 75cm x 75cm	
9	An exhibit of 5 or more kinds of vegetables from your garden not to exceed 1 m x 1 m in size	
10	A bowl or basket of culinary herbs named if possible not to exceed 50 x 50 cm
